Richard Brown (chairperson)

Richard Brown is an attorney with a private practice in Springfield. He earned a bachelor's degree from American International College in Springfield, and obtained his law degree from Western New England College.

After four years in private practice, he served for five years as an assistant district attorney for Hampden County, where he prosecuted chronic offenders before returning to private practice.

Thomas Duane


